Legal Drama: DISH Battles In Court Over Streaming Patents

DISH has entered the court system once again to pursue patent infringement claims, this time against **BBC**- and **ITV**-owned **BritBox**. The satellite video provider filed a suit against BritBox Thursday claiming its online streaming services, including its app, site and servers, infringe upon DISH's patents related to adaptive bitrate (ABR) streaming.

The technology, which was developed by **Move Networks**, allows content delivery to adapt to the bandwidth that is available at any given time to ensure that end users are receiving the best quality video throughout their time streaming. In December 2010, **EchoStar** purchased Move Networks and its ABR patent portfolio for \$45 million, and it has since become a part of DISH's portfolio. Two of the three inventors of the ABR technology remain DISH employees.

DISH claims that it has been trying to reach out to BritBox about the alleged patent infringements for nearly five years. It said it first sent letters to BBC CEO *Tim Davie* and ITV COO/ Executive Director *lan Griffiths* in Nov. 2018 in an attempt to negotiate a licensing agreement. Those efforts continued until the filing of the suit on Thursday. "BritBox's actions have caused DISH to suffer irreperable harm resulting from the loss of its lawful patent rights and the loss of its ability to exclude others from the market," DISH said. "Upon information and belief, BritBox will continue these infringing acts unless enjoined by this court." DISH is asking for a jury trial and for a judgment and order requiring BritBox to pay DISH damages, costs, expenses and pre-judgment and post-judgment interest for its infringement of the ABR patents. It has also asked the court to enter an order that would permanently block BritBox and its officers from infringing or contributing to the infringement of the patents.

This is far from the first time DISH has asked the courts to rule on a matter relating to these patents. Just last month, it filed a similar suit against **Fubo** arguing that the vMVPD had infringed on its patents with its online streaming service. In that claim, DISH said Fubo had been aware of its infringement for at least four years, establishing a first contact in May 2019 with DISH asking the company to talk about a licensing agreement. Similarly to the Britbox situation, a back-and-forth went on until last month when DISH claims fuboTV Chief Legal Officer *Gina DeGioia Sheldon* sent a letter stating that fuboTV did not believe it needed a license.

Time will tell how these suits progress, but DISH has proven successful in the past. DISH sued **Peloton**, **iFit** and **Lululemon** over the ABR patents, and it separately filed a complaint with the **U.S. International Trade Commission** asking for a ban on NordicTrack equipment and Lululemon's Mirror, a smart fitness device with live and on-demand workout classes. Lululemon chose to settle with DISH, but the ITC did institute an import ban on the NordicTrack equipment from iFit and Peloton in March. A judge also ruled that Peloton was infringing on DISH's patents in 2022, but the two companies agreed to settle the

dispute in May.

The ordeal cost Peloton a pretty penny with the fitness technology company agreeing to send a one-time payment to DISH of \$75 million. "We believe our growth agenda is better served by the settlement because it eliminates a cloud of uncertainty and an enormous distraction to the day-to-day operation of our business, despite its adverse impact on Q4 cash flow," Peloton CEO *Barry McCarthy* said in a May 4 letter to investors.

CABLE TV PIONEERS PREPARE TO WELCOME 51ST CLASS, TECH TEN



PAC-12 OVERPAYMENT FALLOUT

The **Pac-12**'s list of issues off the field continues to grow. In January, the conference let go CFO *Brent Willman* and **Pac-12 Networks** President *Mark Shuken* after failing to report an overpayment of \$50 million from what was then labeled an unnamed media distribution partner. That partner turned out to be **Comcast**, and now the actual <u>budget hit</u> the Pac-12 is taking has been revealed to be \$72 million, according to the

San Jose *Mercury News*. Pac-12 commissioner *George Kliavkoff* revealed the figure in a court declaration after Willman and Shuken filed a wrongful termination lawsuit in April. Approximately \$50 million of that is what is owed to Comcast, while the remaining \$22 million is going to the conference. According to the Mercury News—which cites a source—the \$72 million figure can be broken into two ways: distributions withheld by Comcast to offset 10 years of overpayments due to its tracking of Pac-12 Networks subscribers (\$58 million), and reductions in distributions from FY23 and FY24 to make up for a correction in subscriber figures (\$14 million). The withholding and reduction of the \$72 million has already begun and is currently expected to be finalized before the end of the current fiscal year. Both Comcast and the Pac-12 declined to comment.
